## 103. COUNTY COUNCILLOR'S REPORT.

- Slapton Line, Meeting Fri 3rrd Nov. Cllr Moseley was nominated to represent the Parish at meeting.
- Road repair for wall Cllr Brazil reported that closure of road will be 2nd Jan-Mar24. Closure is not Council led, but Amberon are responsible for traffic management for the road closure. Signs will be specific "Road closed at Stoke Fleming", Official diversion will be via Totnes Cross. It was recommended Stoke Fleming Primary School to be warned so that mitigation measures such as 'Walking bus' could be investigated. Cllr Floyd to post details on social media- welcoming ideas to mitigate potential issues. Parish Council to arrange meeting with Amberon and Contractor believed to be Nomad. Owner to be requested to attend (via Cllr Harris.) Cllr Brazil to attend. More details to follow.
